AN ACT Relating to state and local carbon taxes; adding a section to chapter 43.135 RCW; adding a new section to chapter 36.16 RCW; adding a new section to chapter 36.32 RCW; adding a new section to chapter 35.22 RCW; adding a new section to chapter 35.23 RCW; adding a new section to chapter 35.17 RCW; adding a new section to chapter 35A.12 RCW; adding a new section to chapter 35A.13 RCW; adding a new section to chapter 35.18 RCW; and creating new sections.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF WASHINGTON:

INTENT

NEW SECTION. Sec. 1. The people strongly oppose the constant effort by politicians to create and impose new taxes on already struggling taxpayers. This measure would prohibit the state and any local government from imposing a carbon tax.

<u>NEW SECTION.</u> **Sec. 2.** The state and local governments shall not impose a carbon tax.

NEW SECTION. Sec. 3. A new section is added to chapter 43.135 RCW to read as follows:

The state shall not impose a carbon tax.

<u>NEW SECTION.</u> **Sec. 4.** Any local government shall not impose a carbon tax.

Any county shall not impose a carbon tax.

NEW SECTION. Sec. 6. A new section is added to chapter 36.32 RCW to read as follows:

<u>NEW SECTION.</u> **Sec. 7.** A new section is added to chapter 35.22 RCW to read as follows:

Any city shall not impose a carbon tax.

<u>NEW SECTION.</u> **Sec. 8.** A new section is added to chapter 35.23 RCW to read as follows:

Any city shall not impose a carbon tax.

<u>NEW SECTION.</u> **Sec. 9.** A new section is added to chapter 35.17 RCW to read as follows:

Any city shall not impose a carbon tax.

NEW SECTION. Sec. 10. A new section is added to chapter 35A.12 RCW to read as follows:

Any city shall not impose a carbon tax.

NEW SECTION. Sec. 11. A new section is added to chapter 35A.13 RCW to read as follows:

Any city shall not impose a carbon tax.

<u>NEW SECTION.</u> **Sec. 12.** A new section is added to chapter 35.18 RCW to read as follows:

Any city shall not impose a carbon tax.

<u>NEW SECTION.</u> **Sec. 13.** The provisions of this act are to be liberally construed to effectuate the policies, purposes, and intent of this act.

<u>NEW SECTION.</u> **Sec. 14.** If any provision of this act or its application to any person or circumstance is held invalid, the remainder of the act or the application of the provision to other persons or circumstances is not affected.

NEW SECTION. Sec. 15. This act is known and may be cited as "We Don't Want A Carbon Tax."
