Dear Loyal Friend:


Thank you again for your personal financial gift to me and my family. I am deeply grateful for your help.

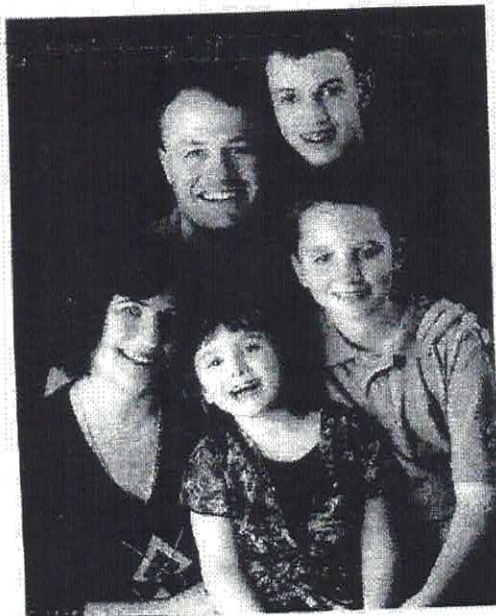
