

# Track record over the last 22 years

I have been fighting for taxpayers for 22 years.

- 1997 – Initiative 200 – banned race & gender preferences (govt affirmative action).
- 1998 – Initiative 691 – lowered car tab taxes.
- 1999 – Initiative 695 – \$30 car tabs and voter approval for tax increases.
- 2000 – Initiative 722 – 2% cap on property tax increases.
- 2001 – Initiative 747 – 1% cap on property tax increases.
- 2002 – Initiative 776 – \$30 car tabs.
- 2003 – Initiative 807 – reestablished state tax and spending limits.
- 2004 – Initiative 864 – 25% reduction in property taxes.
- 2005 – Initiative 900 – state auditor empowered to do performance audits of gov'ts.
- 2006 – Initiative 917 – \$30 car tabs.

**These early initiatives have saved taxpayers \$46.9 billion (2000-2020).**

- 2007 – I-960 set 2/3 vote to raise taxes. **NO TAX INCREASES IN 2008 & 2009.**
- 2008 – I-985 improved transportation using existing taxes instead of raising taxes.
- 2009 – I-1033 capped the growth of government, lowered property taxes.
- 2010 – I-1053 reestablished 2/3 vote to raise taxes after Legislature repealed it. We raised funds but it wasn't enough so I loaned \$250K by mortgaging his home.
- 2011 – I-1125 limited vehicle taxes & I sponsored numerous local city initiatives that banned red-light ticketing cameras (**NO TAX INCREASES**).
- 2012 – I-1185 renewed the 2/3 vote to raise taxes (**2 SMALL TAX INCREASES**).
- 2013 – I-517 protected the initiative process (**NO TAX INCREASES**)
- 2014 – I-1325 pushed for 2/3-for-taxes const. amendment (**NO TAX INCREASES**)
- 2015 – I-1366 pushed for a 2/3-for-taxes constitutional amendment.
- 2016 – Pushed for a 2/3-for-taxes constitutional amendment (**NO TAX INCREASES**)
- 2017 – I-947 "Bring Back Our \$30 Car Tabs"
- 2018 – I-976 \$30 Tabs (sold off family's retirement fund & loaned \$500K to kickstart it).
- 2019 – I-976 \$30 Tabs & Give Them Nothing (stop pay raises for politicians) & Term Limits on Taxes (block 11 tax increases). I-976 overwhelmingly approved.
- 2020 – While running for Governor, I pushed numerous projects including legal defense of I-976 \$30 Tabs and multiple lawsuits challenging Inslee's lockdown (OPEN SCHOOLS NOW, ALL BUSINESSES ARE ESSENTIAL, MASK MANDATE).
- 2021 – "No Income Tax Initiative" and "No Carbon Tax Initiative." Also, working hard to rally citizens to stop tax increases and stop the repeal of tax advisory votes.

Taxpayers have benefited tremendously from these successes. **Please help me survive the AG's political assault. If he stops me, you might be next.**
